Pet food, supplies, and sleeping crates: Non-cash awards of pet food (130,173 lbs), pet supplies and sleeping crates were distributed to non-profit organizations (mostly food banks) across the country to assist with the feeding of pets belonging to the homeless and poor. Pet food and supplies that were purchased by POTH were given to non-profits and/or directly to the homeless.

4b (Code:) (Expenses \$ **243,442** including grants of \$ **179,871**) (Revenue \$)

Emergency veterinary care: payments to 234 hospitals/clinics in 33 states to assist emergency treatment of 767 pets of homeless persons. All treatment expenses are paid directly to the hospitals, not to individuals.

4c (Code:) (Expenses \$ **21,827** including grants of \$ **16,160**) (Revenue \$)

Wellness clinics: Awards to 9 hospitals/clinics or non-profits in 6 states that performed 44 wellness clinics in various states to 979 pets. Wellness clinics include a basic exam and vaccinations. Sometimes with spay/neuter procedures performed at the location of the clinic. The sponsorship requires that reporting be done within 120 days from the date of the clinic visit. Visits that took place after September may not be reported until 2018.
